Kinshofer GmbH from Germany and the in the United Kingdom based company James Fisher-Prolec (Prolec) announced today that they have signed a definite agreement to merge. Under the terms of the agreement Kinshofer has acquired 100% of Prolec's shares.

For over 50 years, Kinshofer has been a leading manufacturer of tools for truck mounted cranes, excavators and skid steer loaders, consistently developing its product range in both, the crane and excavator markets to become a competent and reliable partner for OEM's and OED's. Previous acquisitions of Liftall Inc. (Canada), Demarec B.V.
